5. 如因貨存問題而需進行退款，全額網上訂金將以支票形式退回，處理時間將不少於 10 個工作天。

2. Your order will be confirmed after successful submission of the form and timestamped upon receipt of the MOP\$5,000 online deposit. You will receive an email confirmation upon a successful order. Once the vehicle enters the production stage, a representative from BMW Concessionaires (Macau) Ltd ('BMW Macau') will notify you about the production schedule.
3. The production quota of the selected model will be allocated according to the timing of your deposit placed on the BMW #NEXTGen website.
4. The online deposit MOP\$5,000 made via BMW #NEXTGen website is non-refundable, and will go towards the vehicle's deposit in the purchase agreement.
5. In case a refund is needed, the online deposit will be fully returned to you via cheque, and processing time would usually not less than 10 business days.
6. If you want to change your selected model, you may alter your selection to another new BMW model prior to signing the formal purchase agreement.
7. The models, accessories and prices shown on BMW #NEXTGen website are for reference only; the exact appearance, equipment and price may differ from the physical vehicle model.
8. You agree you are at least 18 years of age when making use of online consumer contents or making an online purchase and you agree to all terms & conditions and our privacy policy. No refund will be granted however for use of a credit card without the cardholder's consent or the use of a false identity to reserve a vehicle. An order made under such circumstances will automatically be cancelled.
